Amir Shabani is a professor of psychiatry at Iran University of Medical Sciences (IUMS) and a research psychiatrist at Mental Health Research Center.

His major research interest is clinical issues of bipolar disorder and posttraumatic stress disorder (PTSD), especially clinical picture, comorbidity, compliance, quality of life, clinical course, and outcome.

He conducted the study called Bipolar Disorder Patients Follow-up (BDPF) that followed a group of patients with bipolar disorder type I for 7 years, “Evaluation of 4030 Call Center Psychological Counselling Services Performance” under the supervision of World Health Organization, and “Adaptation of Clinical Guideline for Management of Iranian Adult Patients with Bipolar Disorder”.

He has written a series of academic books in Persian called “Psychiatry through Clinical Cases” including three volumes: 1) Psychiatric education through clinical cases, 2) Psychiatric emergency through clinical cases, and 3) Psychiatric consultation through clinical cases. The co-authors in this series include eight psychiatrists.
